

# **Tapestry Policy**

#### **Policy statement**

In Darul Madinah are using the online observation system to record the children's learning. The online learning system is called tapestry. This will be used to record observations, photos and videos. All parents will be given the opportunity to sign up for this service and be part of their child's learning journey. Parents will also be able to add their own observations and photos onto tapestry once approved by the manager. This will give Dar-ul Madinah a chance to build a stronger partnership with parents. Children continue to develop from the date they start preschool until they leave for their reception class. This development can be shared between the nursery and home.

#### **Procedures**

In Darul Madinah we use a secure online observation system called tapestry which can be used by parents and staff with a secure login and password to access the information. A key person is allocated to each child, it's that key person's responsibility to develop and complete the learning journey of that child. However other key person can also record activities of other children who they are not key person for. For example, if staff members see a child doing an activity they can also log into the learning journal. Parents will only have access to view their child's learning journey. Other children may be in photos with your child if the observation is of a group activity with the consent from the parents. Parents can also log into the system and add observations of their child which will be sent to the manager for approval to makesure the content is appropriate. Parents can also comment on observation but this will not be used as a communication tool between staff and parents. Before we link children to other children's observation permission will be taken from parents in a form of a letter explaining the guidelines of tapestry and requested permission. Before accessing the system, parents have to sign to agree not to download and share any information on any other online platforms or social networking sites (such as Facebook). Whilst Tapestry provides a fantastic tool for sharing information between the pre-school and parents, it is not used as a way of sharing general communication. Each child's learning journal is a document to record their learning and development which parents can add comments on or contribute to with information of what they have been doing at home. Any further discussion of progress or concerns will be done during a face to face conversation at the setting during a prior agreed time. Observations are regularly monitored by the managing staff to ensure they are providing relevant and informative information.

Dear Parents and Carers.

#### Salaam

I hope you are all in good health and imaan. All children attending Dar-ul Madinah have a personal online Learning Journey which records photos, observations and comments, in line with the Early Years Foundation Stage, to build up a record of your child's experiences during their time with us.

We use Tapestry, an online system, which is hosted within the EU on secure servers. Further security details are available on request. The benefits to yourselves from Tapestry being on-line means you will have secure access (via a website or mobile app, which you login to using your email address and a password) to your child's Learning Journey and, in addition to viewing our contributions, we encourage you to add to it by uploading photos and comments, or commenting on observations made by us.

The nursery has a secure Tapestry website, which once you have provided the nursery with an e-mail address we will be able to set you up with an account. We will also give you detailed information on how to view/use your child's Learning Journey. If you do not have access to e-mail your child is still able to have an online Learning Journey which you can access through the use of nursery computer equipment during specific dates throughout the year. Each child will receive a CD with their Learning Journey on at the end of the Nursery Year.

Many of the most meaningful photographs taken in pre-school show children interacting in group play or activities with peers, we therefore ask that these photos are for your own viewing and not shared publicly or uploaded onto any social media websites, this is in line with our 'our tapestry policy' and 'Mobile phone/camera' policies (both are available to view in pre-school or can be sent by email upon request, failing to up hold this request will result in suspending your child's online Learning Journey. We also ask that if you become aware of this happening you inform Dar-ul Madinah immediately.

In order for your child's Learning Journey to be created please give us permission by completing the attached slip. Also if you provide your E-mail address we will set up an account enabling you to access your child's learning journey via the secure Tapestry website for your child. (Please note each parent only has access to their own child's Learning Journey)

If you have any questions or queries about the on-line Learning Journeys please do not hesitate to ask the nursery manager.

### **Staff Tapestry Agreement**
